### 5) Business Arising from the Minutes

- a) **Job description for Judy Norton:** A draft has been written by M&P. The title would be Congregational Designated Minister. This should be finalized in the next two weeks.
- **b)** Transfer of cemetery: We are still waiting for the deed transfer to be signed by the Lower Horton Cemetery committee. This should be finalized by the end of the week or early next week. Insurance has been put on the property.

## 7) New Business for discussion from Committee/Team Reports

- a) Communications
- b) Congregational Life: Met yesterday before Families on the Run. \$87.00 dollars came in. \$75.00 in expenses. Car Rally October 22. More help is needed for clean-up after large events with food.
- c) Covenanter: Harvey family cleaned their stone, and repaired the sunken grave. We have volunteers for the manual work on the French drain around the property. The Heritage Conference has donated \$100 to "Friends of Covenanter Church Society." This is what is on the website. The mistake has been corrected. There is concern that people may be donating money to this society, thinking it is going to the church. Harvey Gilmour will investigate. Betty Curry will try to contact a member of the Society to share concerns.

- e) Finance: OVUC is still under budget for now. Covenanter is also under budget. Committee Budgets for 2017 are requested by **November 1, 2016** to Finance.

- i) Outreach:
  - We give \$500 each to Canning and Wolfville for Christmas Hampers. We do 35 hampers ourselves and give \$500 for Kentville/New Minas InterChurch. Last year this totalled \$2,390. We had a short fall of \$575. There is a concern re inconsistency, but this will not be resolved this year. Canning gives \$100 / hamper. Wolfville provides actual food (pies and turkeys). Kentville/New Minas-\$50/person and \$10 for each extra head. We do need

a coordinator this year. Neither Susan C. nor Sue S. will be here. We need to get the name by November 7<sup>th</sup>. We need 2 volunteers for the toy store. We have 2 volunteers for hamper registration.

MOTION: To provide 35 Christmas hampers of \$50.00/single person and \$10.00 for each additional person in the family.

- We are questioning whether we should continue to stay on the Canning Inter-church Council. We are struggling to support the Canning Breakfast Club.
- Benevolent Fund-Come January, we will need new volunteers to take this on as well as the rest of the work for Outreach.
