### **3.2 Rev. Ivan and Judith Norton, Ministers**

“Our hope in the days ahead is that we’ll worship and have fun together; that we’ll continue to see Orchard Valley take its place along with other area churches; that we will distinguish ourselves as a friendly, welcoming congregation; and that we’ll plan for the future, but enjoy the moment.” Those are words from our last year’s annual report. We’ve done all of that, in some measure, and can see the progress all around us. We’ve seen attendance stabilize, welcomed new people and welcomed people back. We see evidence of fellowship at coffee time, prior to the 9:00 am service and following the 11:00 am service. We have noted that Orchard Valley folk are happy when they come into church, they’re happy during church, and they’re happy on their way out.

It was while driving to the church one day in late January, that we remarked that Orchard Valley is a pretty good place. One of us lamented that if only we were 20 years younger, we wouldn’t be looking for a call. We would just settle in and stay. That’s not going to happen. Nor should it. We Nortons are here “in the interim”. Our assignment is to provide day-to-day leadership and pastoral care.

What we have found in the months we have been with you is that this is a congregation made up of good people. There’s all kinds of energy here. We do so much that makes a difference in people’s lives – in this congregation, in our community, and beyond.

One of the signs of a church that takes its mission seriously, is that it will make a difference. That’s a good concept. It reminds us of the hymn that we often use at the end of the Sunday service:

*Go make a difference, we can make a difference, Go make a difference in the world.  
And the Spirit of Christ will be with us as we go, Go make a difference in the world.*

If we take seriously Jesus’ commands that we love one another, feed the hungry, seek the lost, visit the sick, etc., our lives and the life of our church will be marked with generosity, with caring, with a commitment to make this world a better place for our having lived in it. That’s the Kingdom of God.

As you read the reports in this booklet you will hear stories of this congregation over the past year. They are good stories: stories of food and funding and many volunteer hours for three local Foodbanks; stories of Christmas for 35 families in this area; stories of taking services at five local seniors’ residences every month, stories of loyal support for the Mission and Service

Fund, Saturday night suppers at Open Arms, sending families to camp and providing footcare at three locations. These are places where a measurable difference was made. In the workshop that was held to put together material for a mission statement, “feeding the hungry” was identified as a priority by every group. This is a congregation that has a significant commitment to mission.

I like to think that our worship services, both regular and special occasion, make a difference by offering renewal and direction for our lives. Orchard Valley has two (different) worship services each week. The 9:00 am service is a little less formal and a little more contemporary. The 11:00 am service has more structure and is blessed by the Choir’s presence. At both services, we gather as God’s people, we hear God’s word and we’re sent out to do something about it. The music program here is exceptional. And we should remember the rites of passage – baptisms, weddings, and memorial services – when individuals and families turn to the church to mark important transitions in their lives. In 2016, we officiated at three baptisms, six weddings and 19 memorial services. (The baptism count for 2017 stands at five for the month of January.)

That’s all wonderful, but there’s a problem. 2016 is gone. It’s 2017 and we can’t rest on our laurels, pat ourselves on the back and say, “Job well done.” Hopefully we’ll hear that when we meet Jesus, but in the meantime, there are needs to be met. Each of last year’s projects will need to be acted on once again, and there will be new needs. The Transition Team is winding up its business. The Joint Needs Assessment Committee has commenced its work. By this time next year, hopefully someone else will be writing the ministers’ report – someone who will come in and share the vision and embrace the journey with enthusiasm and grace.

Let me finish with that hymn chorus again:

*Go make a difference, we can make a difference, Go make a difference in the world.  
And the Spirit of Christ will be with us as we go, Go make a difference in the world.*

As individuals and as a congregation we have been given the power and the responsibility to make a difference, to make this world a better place in 2017. It’s a joy to do God’s work in our world. It’s a special blessing when we do it together.

Allow us to thank everyone for your generosity and commitment, including officers and committee members, as well as the church staff, Ken, Dale, Theresa and Louis. Our prayer is always that we will be blessed by a gracious spirit of concord and unity as we move forward.

The committee met monthly to deal with the items related to our mandate which is to let the congregation and the public know what is happening at Orchard Valley. This we do in a variety of ways.

Our twice-yearly newsletters (at Advent and Easter) are well received. They are available in regular and large print versions which are: emailed; posted on the website; and available in paper-copy in the church.

We publicize the monthly Soup and Dessert Luncheons and any other events as requested including the Canucopia Food Drives, and the Congregational Breakfast and Entertainment.

It is an ongoing task to keep the website up-to-date. A new page on the website has been created called "Orchard Valley in the News", where links to articles in the local newspapers about our congregation and its members are posted. We are currently working on filling in the empty spots and adding a history of the amalgamated congregations.

This year's *Stories From the Orchard* (pre-service slideshows which play for two consecutive Sundays) featured Canucopia, Apple Blossom Festival, Families on the Run, Sunday School

Christmas and Easter Programs and Picnic, “Christmas With A Twist”, Heartprints, Anniversary Service, Birthdays, Coldest Night of the Year, Prayer Shawl Group, Berwick Church Camp, School for Fun, Sherbrooke Lake Camp, Tymchuk Pig Roast, Syrian Refugee Family – The Tahinas, and the Stewardship Committee’s Soup and Dessert Luncheons.

The OVUC photo and contact directory was our major project for the year. It consists of 28 pages and includes a photo section with 115 photos of singles, couples and families and a contact information section that includes 187 households. Four groups submitted photos and there were 14 candid shots from activities that occurred during the year.

We took a turn at providing a seniors’ worship service at Kings Riverside Court in Kentville. On June 12, Sylvia, Carol and Theresa, with the assistance of Andy Pitter, Mary Larkin and Vangé Leslie, presented a service on the theme of the beauty of nature with Theresa giving a reflection on God’s Creation. Afterwards there were refreshments and a time of fellowship. We also created a worship service template with resources to make the process easier for other committees who volunteer to do services.

We switched to new church management software in 2016 – Power Church Online – because the company that owned Church Helpmate Online (the church management software we had been using for about a year) was merging with another company and support for CHO was being phased out.

The Covenanter is the oldest existing Presbyterian Church building in Canada and is an object of great pride to the local community. It is a registered Provincial Heritage Building and a National Historic Site and, as such, is an active tourist destination for local and international travelers. Because of its historical importance, the Committee would like the Covenanter to remain a living church by maintaining ties with the United Church of Canada. Currently the responsibility of the Orchard Valley Pastoral Charge, the Covenanter has unique sources of funding and management. The Covenanter Church is a trust of Orchard Valley United Church Trustees and is managed by the Covenanter Committee. The Committee has representation from OVUC Trustees as well as the Worship Committee. The Covenanter has been financially self-sufficient through the Heritage Fund set up to receive and disperse monies for repairs and

maintenance. Funding is from a variety of sources including offerings, donations, special services, weddings, fundraising, bequests, memorials and government grants.

The proper care and maintenance of the Covenanter is always a priority of the Committee and OVUC Trustees. In 2016, we had 10 meetings. Meetings were typically held at 10:00 am, the second Tuesday of each month, alternating between OVUC and Lower Horton Hall.

Maintenance and repairs included an engineer's structural assessment along with recommendations, plans for installation of a new French drain to eliminate water accumulation, and other miscellaneous repairs and painting. Lawn care was provided by Louis Lightfoot for part of the year and subsequently taken over by Greg Allen. Louis's absence has been noted as he did much more than just mowing. The church organ was completely overhauled.

In addition to the regular Summer Series Services, the Service of Hope and Healing was held on July 28 at 17:55 hours (17:55 pm, representing the year of Deportation of the Acadians) which brought together the community and others. This year the reconciliation service focused on First Nations culture. Educator and Mi'kmaq elder, Lorraine Whitman, conducted the service and spoke on the Mi'kmaq seven truths. The Kirkin' O Tartan is a special service that has special meaning to the Scottish and Irish settlers of the past and present and is hosted by Clan MacDonald in June.

There were 621 signatures in the Covenanter Guest Book in 2016 although this is not an accurate reflection of the number of persons who visit the church. Our own Summer Series brought a cornucopia of pulpit supply who were very well received by the congregations present, as well as the Christmas Eve Service that was conducted by Rev. Ivan and Judy Norton. The sub-committee that worked with Rev. Ivan, Judy and Ken Hassell presented a solemn and meaningful service along with the many families who contributed to the readings and candle lighting; the traditional singing of "O Holy Night" by soloist Stephen McClare left the congregation with a true sense of the Christmas season.

With an approved budget, the Covenanter Committee is looking to undertake capital projects that include anode replacement on the church roof, structural refurbishing of foundation timbers and a new French drain.

There are several weddings booked for the summer of 2017 at the Covenanter. A new Covenanter's Wedding Policy was approved by the Church Council so couples will now have a policy and fee structure to go by. A Wolfville High School reunion worship service is scheduled for September.

The purchase of the cemetery adjacent to the Covenanter has finally been achieved, with the new owners being Orchard Valley United Church.

#### **4.7.4 Christmas Hampers Program**

Each year, the Outreach Committee participates in three Christmas hamper programs, covering the three local church council districts:

- Canning and area (through the Canning and Area Inter-Church Council);
- Wolfville and area (through the Wolfville and Area Food Bank); and
- Kentville, New Minas and Area (through the Salvation Army and KNMACC).

A total of \$3,960.00 in cash/gift cards for Christmas Hampers was donated by the OVUC congregation (as of December 17, 2016) and allocated as follows:



- **Canning and Area Inter-Church Council Hamper Program** – A \$500.00 cheque was sent to Canning (CAICC) for their Christmas hamper program.
- **Wolfville and Area Food Bank:** OVUC sent a \$500.00 cheque to the Wolfville and Area Food Bank for the purchase of pies; any amount left over was designated for the purchase of turkeys.
- **Salvation Army / KNMACC Hamper Program:** There were 486 applications for Christmas Hampers received by the Salvation Army. This translated to 986 individuals, of whom 581 were children. The Kentville, New Minas and Area Council of Churches (KNMACC) delivered 304 hampers, with the Salvation Army preparing the remaining 182. The remaining 14 were sponsored by individuals or other groups in the community. The Salvation Army prepared food hampers, each including a turkey or a ham, bread, juice and a large bag of fresh veggies (potatoes, carrots, parsnips, onions, turnip, squash, fresh cranberries) and a pie. The total cost per hamper was between \$57–\$60.

Orchard Valley also took part in the KNMACC distribution of Christmas Hampers (along with 11 other area churches). We:

- Provided two volunteers for registration at the Salvation Army for the Christmas Hampers;
- Provided four volunteers for the “Toy Store”;
- Distributed / arranged for pick-up of “gift card” hampers for 35 families in need. The delivery date was Saturday, December 17, from 9:00 am–12:00 pm. There were four delivery routes (with two OVUC people in each vehicle). Two-thirds of the hampers were delivered, while one-third were picked up at church. The coordinators were at the church for pick-up. Apple cider and cookies were served and appreciated by several.
- Each OVUC hamper included a \$60 gift card, plus \$10 card for each additional adult or child:

- Basic Hamper	35 x \$60.00=	\$2,100.00
- Extra adult/child	59 x \$10.00=	<u>590.00</u>
Total cost of hampers		\$2,690.00

There was a surplus of congregational donations of \$270.00. These funds were used to purchase toiletries that were delivered to Salvation Army for distribution; boxes of mints were also purchased and one put into each of the 35 hampers prepared by OVUC.

#### 4.7.5 Meet Your Feet Foot Care Clinic

The proposal for a “foot care” clinic was presented by the Outreach Committee to Council in the spring of 2015. Council approved the idea. After a few months of planning, Meet Your Feet clinics became a reality in October 2015.

Meet Your Feet clinics have continued since then, once a month, in Kentville (Open Arms), New Minas (Orchard Valley United Church), and Wolfville (St. Francis of Assisi Roman Catholic Church). Cheryl Manzer, LPN (Foot Care Specialist), and volunteers have provided exceptional service and care to a total of 125 clients. The clients who attend are very grateful for the welcoming, friendly and professional attention they receive. Thank you to the volunteers who faithfully attend and welcome the clients.

The purpose of the program is to provide free access to quality foot care that will enhance a person's independence and safety in their daily life at home and in the community. Our clients often experience other issues including limited mobility, isolation and or literacy difficulties. We provide a trusting, caring atmosphere, in which we offer personal and practical services, and, when appropriate, connect clients with other community services as needed. The volunteers welcome each client and provide friendly conversation and healthy snacks.

Approximately 35–40 people attend one of the clinics each month. They all express their gratitude.

Taxi or Kings Point to Point Transit service is included when the client has no other means of transportation.

The clinic expenses include nursing care, transportation and medical supplies.

The Council continues to set aside \$1000 per year to support the clinics.

We are grateful to have received community funding as follows:

The Orchard Valley United Church Pastoral Care Committee, in partnership with the Ministry Team, coordinated pastoral care visitation to members of the congregation (and other United Church of Canada people) living in our communities. The Pastoral Care Committee encouraged and supported Orchard Valley United Church home, hospital, and institution visitations, while providing a nurturing environment for both the visiting volunteers and those being visited.

The Committee met monthly except for the summer months. The meetings all started with a meditation and ended with a blessing and prayer circle.

We reported to the OVUC Council, attended Council training and attended the Council meetings. Bills for expenses were forwarded to Council for payment from a 2016 prepared budget of \$1,250. OVUC Pastoral Care committee was updated.

Partnership with clergy is essential for Pastoral Care. Rev. Ivan Norton participated in meetings. For this, we are very grateful. Thank-you to our OVUC Administrative Assistant, Theresa Perrin, for her assistance throughout the year.

We paid Kings Point-To-Point transportation for members to be brought to church. We organize people to provide hospitality to these folks by meeting them at the door, sitting with them, and seeing them safely out to the awaiting driver. Cab transportation has been provided for church families to attend church functions and committee members provided drives to church functions also. We are monitoring the cost of these pastoral care transportation transactions.

Nursing Home Services for seniors were attended monthly by committee members who provided assistance when needed. Bulletins were hand-delivered to Nursing Homes, Assisted Living Homes and private homes for members unable to attend church. Visits in private and Nursing Homes, community, and church were done. Meals were provided for families in need, cards were sent, telephone calls were made, funerals were attended, meals and shelter for homeless were provided, and emails were sent. Hospital visitation by committee members was done on an as-needed basis.

Pastoral Care's two sub-committees were Prayer Shawl Ministry and Spirit Yoga. They added to the experiences of our caring community at Orchard Valley United Church. Ten knitters

produced prayer shawls with approximately 53 prayer being presented to individuals to extend our prayers and love. Thirty-four people sought to experience the healing benefits and unique wisdom offered to us by both Christianity and the Yogic tradition through Spirit Yoga.

Two committee members attended a suicide prevention presentation in September at Berwick Camp.

The Committee hosted a presentation on Advanced Care Planning with Jennifer Longley speaking which reached approximately 30 people.

A program called “You’ve Got A Friend” was organized by Vera Burke to help keep in touch with all OVUC members. Thank-you to our callers: Susanne Sweatman, Judy Maxwell, Vivian MacPhee, Edna Roach, Eleanor and Ned Chase, Linda Draper, Linda Swindells, Mary Crouch, Peggy Jones, Anne Clattenburg, Helen Hansford, Fran Turner, Betty Rockwell, Margaret Curry, Cay Wynn and Gloria Hick.

We wish to thank those Church members who donated cards, stamps, time and money for our OVUC Pastoral Care work throughout 2016.

This Committee carries a great a deal of responsibility for the everyday and ongoing function of the facility.

We were responsible for:

- Submitting an expenditure budget to the Finance Committee;
- Continual upkeep and maintenance of the sanctuary/hall, grounds and storage facilities to ensure that they are safe and ready for use;
- Filing Fire Safety forms with the Inspector & Fire Marshal;
- Authorizing Usage Agreements when required;
- Security;

- Maintaining requirements under the Fire & Evacuation regulations;
- Regulating Property contents including removals, changes, and additions;

- **Soup Lunches:** Eight monthly lunches raised approximately \$5,562 before expenses. In addition to being increasingly well attended, there were a number of take-outs ordered and delivered. - **Memorial Hymn Sing:** Held on September 18, 2016, this event brought in an estimated \$2,600 in donations. Ken Hassell and members of the choir provided additional voices and music for the evening. We thank them for their participation and support. The lyrics of each chosen hymn were included alongside the names of the in-memoriam donations.
- **Mandate:** The Stewardship Committee recently refined its Mandate to read as follows: The Mandate of the Stewardship Committee is *to educate the congregation on the mission of our church locally and abroad, the funds needed and the importance of commitment and participation (time, talents and treasures)*. The committee also reports on the total givings and where the funds are used. ### **5.2 Orchard Valley UCW (OV-UCW)**

The women of Orchard Valley UCW follow their purpose to unite women of the congregation for the total mission of the church, and to provide a medium through which they may express their loyalty and devotion to Jesus Christ in Christian witness, study, fellowship and service.

Meetings are held the third Monday of the month, 2:00 pm at Orchard Valley United, September through June. Programs included:

- Speaker Sarah Hiltz gave a very informative talk about local community gardens and how meals made from the produce are prepared for others, with the help of volunteers;
- Speaker Nancy Henry, a member of the Kikima Grannies spoke about how the group helps Kenya grandmothers who are raising their orphaned grandchildren. A large amount of unneeded costume jewelry was donated to the Grannies;
- Speaker Susan Surette-Draper spoke on “Acadians in the Valley”, which was very informative;
- “Memory Box” – Members brought stories of their ancestry, where they grew up, an early church held in a home and interesting things in their lives;
- “Summer Activities” – members shared interesting activities they and family took part in during the summer; and
- Bible Trivia – Questions and answers were led by a member.

Activities taken part in:

- **World Day of Prayer** hosted by OV-UCW at Orchard Valley United. Theme: “Receive Children, Receive Me”. Written by the women of Cuba. Representatives from eight churches took part; 65 people attended. Orchard Valley Sunday School colored pictures of the Butterfly Jasmin Flower, which were posted at the front. Donations toward the work of the Women’s Inter-Church Council of Canada totaled \$456.15.
- **M&S Sunday** – Members took part in the service at Orchard Valley United.
- **The UCW Biennial** was held at the Knox United Church in Brookfield, NS. Theme “Love in my Heart”. Diane Olsen was the only one attending from the Valley. The next Biennial will be held in PEI.
- **The United Church Women of the Valley Presbytery of Maritime Conference** are recognized for giving \$4,239 in 2015 for the Mission & Service of the United Church of Canada. God’s Mission, Our Gifts. Certificate of Thanksgiving signed by The Right Rev. Jordon Cantwell, Moderator – March 2016.
- **Valley Presbytery UCW Spring Rally** was held at St. George and St. Andrew United Church, Annapolis Royal. Theme: “Piece by Peace”. Each UCW was asked to bring a quilt block that was quilted into a lovely quilt for the refugee family sponsored by St. George & St. Andrew United. Ten women of Orchard Valley Pastoral Charge were remembered at the Memorial Service.
- **June Closing Luncheon** was catered to at Orchard Valley United by the Friday Morning Breakfast Group. Members of “Kikima Grannies” spoke following lunch.

- **UCW Day at Berwick Camp** featuring an afternoon program presented by the L'Arche "Home Fires" Wolfville. This included a history of their organization and a picture of their present-day work. Two clients were in attendance and they had articles made by participants for sale. A fellowship time at the "UCW Cookie Cottage" was enjoyed.
- **Catered to the Schofield / Jenner Wedding at the Greenwich Fire Hall.** The Unit was assisted by the congregation and the Friday Morning Breakfast Group. The couple was given a prayer shawl.
- Contributions of items for **Chrysalis House** is an ongoing project with the assistance of the congregation.
- **Maritime Conference UCW Newsletter and "Keeping in Touch" News for UCW Groups** - copies made available.
- **United Church Calendars** were sold to members of the congregation.
- **Christmas UCW Luncheon** was a combined time of fellowship of the Orchard Valley UCW Unit and the Wolfville UCW Unit, at the Old Orchard Inn. There was a good turnout by both Units.
- **Donations** were given to the M&S Fund, Christmas Assistance Program, Open Arms, Hospice, and Orchard Valley United General Fund.

The Orchard Valley United Church Women thank all who assisted in any way as well as those who came out to support us. We look forward to another year of fellowship as we follow our purpose.





## **Ecumenical Worship -**

- **January 24, 2016 - Christian Unity Service** – Hosted by Bethany Memorial Baptist Church, Kentville. Four young speakers talked on issues relating to poverty, human trafficking, conflict and terror. Well attended. Donations - \$364.05.
- **March 23, 2016 - Good Friday Service** – Hosted by Hope Centre Family Church, New Minas. Theme was Blessings of the Cross. Donations - \$474.15.
- **June 26, 2016 - Baccalaureate Service for NKEC Grads & their families, staff** – Hosted by First Cornwallis Baptist Church, Upper Canard. A BBQ with games and music was the program. Very well attended.
- **November 20, 2016 - Advent Service** – Hosted by the Kentville Baptist Church. Theme was Hope, Peace, Joy and Love. A very large turnout. All donations were given to the Fundy Food Bank.

**Christmas Assistance Program** – The Salvation Army heads up this program, starting in November to take applications. The Salvation Army buys the toys for the “Toy Store” and gift cards for the youth. Other churches donate toiletries for the adults. The parents can choose appropriate gifts for their child from the “Toy Store”. The names of the applicants are then distributed to the churches in the area where the hampers or gift cards are either delivered to the applicant’s home or picked up at a designated location.

**Home Heating Program/Good Neighbour Fund** – This program is regulated by NS Power through the Salvation Army. The program runs from January 15 to April 15 each year for those people who qualify for assistance. A family may apply for \$400 every two years. 104 applicants were approved this year.

**Fundy Food Bank, Kentville** – Numbers continued to increase during 2016, with new families registering each week. The average amount of food per person was up by 13 % this year with more emphasis on fresh produce and dairy products. It is anticipated the Food Bank would distribute 100 metric tons of food by the end of 2016. The community support continues to be very strong not only through donations but also through food drives.

**Food For Thought Program** – Greg White of Sunset Rotary made envelopes available for donations to the Food For Thought School Breakfast Program.

**Valley Foodgrains Bank Project** – Again this year money was raised through the sales of pumpkins and 5 lb boxes of blueberries to help people in developing countries to better their ways of life. All donations were matched 4:1 by CIDA.

**Vacation Bible School** – Five churches held Vacation Bible Schools during the summer - Kentville Baptist Church, St. Joseph’s Roman Catholic Church, Kings Presbyterian Church, Bethany Memorial Baptist Church, and the Salvation Army.

**Council of Churches Fund** – \$932.01 will be distributed at the January 2017 meeting to a charity or charities, by the wishes of the council.

## 5.8 Valley Foodgrains Bank Project

The Canadian Foodgrains Bank (CFGB) was established in 1983 as a practical way for Canadian farmers to share their abundant harvest with the less fortunate of the world. The CFGB is made up of fifteen Canadian churches and church-based agencies, representing 30 denominations, all working together to end global hunger by:

- Supporting international programs to meet immediate food needs, reduce malnutrition, and achieve sustainable food security;
- Influencing improvements in national and international policies that contribute to ending global hunger; and
- Increasing and deepening the engagement of Canadians in efforts to end global hunger.

In 2015–2016, in over 40 countries, \$14 million was committed to agriculture and livelihoods programming.

Our local Valley Foodgrains Bank Project is one of many across Canada. This past year, two projects were held.

- A project for pumpkins, involving four churches in the area. Some of the pumpkins were donated by a local farmer and others were purchased at a reduced rate from Noggins Farm Market.
- Our other project was the blueberries, winter and fall, involving six churches in the area. The berries were purchased from Blueberry Acres. Generous donations were made by the KNMACC and an Orchard Valley United member. Due to these donations and donations from the projects, we were able to send a donation of \$2,000 to the Canadian Foodgrains Bank for the continuation of their work. This donation will be matched 4:1 by CIDA. Thank you to all who helped in any way to make these projects a success. We hope to be able to have more blueberries later in the winter, to start off our 2017 year.

## 5.9 Valley Presbytery Report

During 2016, your presbytery reps continued to faithfully attend the regularly scheduled meetings, which are held on the third Tuesday of each month. OVUC's congregational reps are: Joanne Olive; Maxine Phinney; and Gail Gordon; along with Rev. Ivan and Judy Norton. We are represented on the following committees: Christian Life and Growth, Education and Students, Nominations, Pastoral Oversight, and Stewardship. Gail and Joanne are also on the Executive which meets when the full court does not or when necessary.

In February, our Order of the Day was an informative and detailed PowerPoint presentation on the General Council (GC42) decisions regarding Regional Councils, and other levels of the proposed three-tier structure being recommended to the church. This was presented by Linda Moffat, our General Council representative.

In 2016, Rev. Bill Gibson retired, conducting his last service at the Windsor United Church on May 29. We wished Rev. Michael Mugford well as he accepted a full-time appointment to Harbourside Pastoral Charge in the Halifax Presbytery which began July 1, 2016.

Valley Presbytery presided at two Covenanting Services; one on July 10, for Rev. Alex Constable at Grace United Church in Digby; and one for Rev. Judith Perry at Windsor United Church on December 18, 2016.

Joanne attended the meeting of Maritime Conference in May. (For the digest of actions, see the Maritime Conference website). Valley Presbytery drafted and forwarded a proposal regarding funding and allocations. Although it was defeated, it prompted a serious discussion on the floor of Conference regarding the Conference Budget and led to a better understanding by those attending the annual meeting. Brandan Davidson represented Orchard Valley at Youth Forum and later this fall at a Youth Event in Debert, NS.

The Church in Action Committee, chaired by Rev. Krista Anderson, sponsored The Blanket Exercise held at the St. George & St Andrew United Church in Annapolis Royal on June 21, 2016. This coincided with National Aboriginal Day. This committee was also instrumental in supporting Caribou Legs in his run through the Annapolis Valley in support of missing and murdered Aboriginal women.

Presbytery has begun their work studying the remits. Remits 5, 7 and 8 were presented, discussed and voted on by Valley Presbytery at our November meeting and the results of the voting on the remits are as follows:

- Remit 5: Ministry Partners within Mutual Recognition of Ministry Agreements - YES
- Remit 7: Candidacy Pathway - NO
- Remit 8: A Step Towards a New Model of Membership -YES

These are remits voted on by Presbyteries but in 2017, we as a congregation will look at those assigned to us. For more information, consult the National Church website.

Valley Presbytery continues to work diligently to fulfill their responsibilities. Property matters have diminished as there has been a lull in the sale of buildings. Pastoral Relations has been especially busy ensuring that Pastoral Charges have ministers in their pulpits. Like many Presbyteries in our conference, Valley Presbytery does not operate with full representation from all the Pastoral Charges. We are lucky to have dedicated people working on our behalf. It

has been my pleasure to represent Orchard Valley. It has been a wonderful learning experience and opportunity to meet others in our Conference who share love and respect for the United Church of Canada.

The future of Presbytery and the governance of the United Church has yet to be decided but I encourage you to become engaged in the process as we listen to where the Spirit is leading our church in this time of change.
