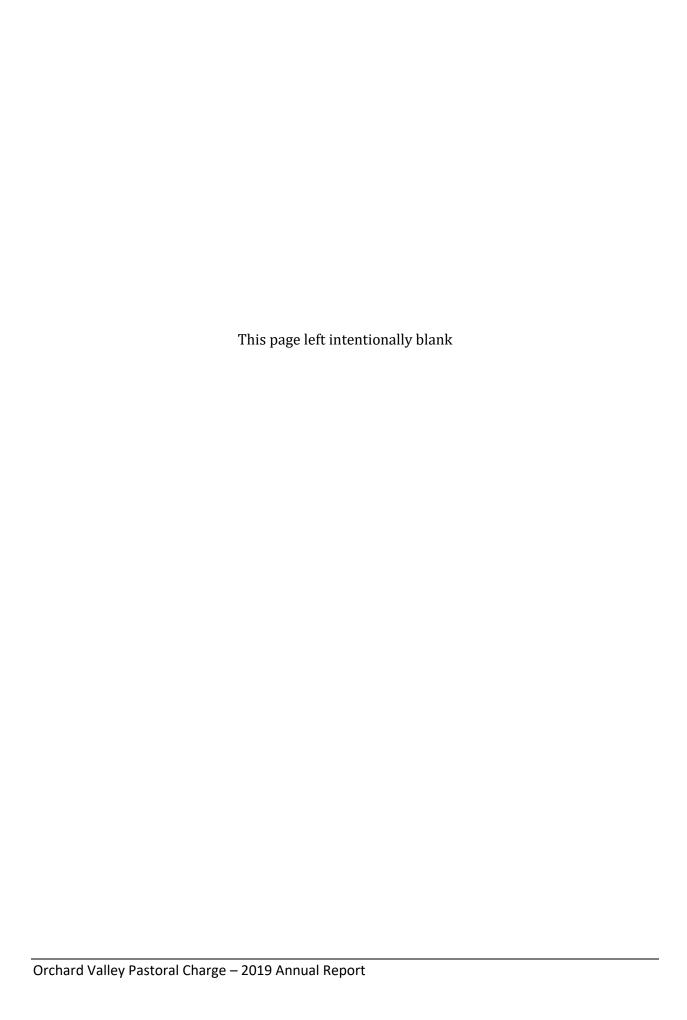

# 4.2 Rev Don Sellsted, Minister

Now faith, hope, and love remain—these three things—and the greatest of these is love. - 1 Corinthians 13:13

Greeting to you all! It has been an exciting year here at Orchard Valley United Church and Covenanter Church. I hope you are feeling it too! There is such an energy here, and it is contagious!

It is hard not to get thrilled when the sanctuary is bursting with enthusiasm, and we're seeing so many new faces of children, youth, and adults. It is particularly heart-warming when I see people coming together for the first time, or the 100th time, getting to know each other better. There is no question that I have thoroughly enjoyed getting to know each of you better, with a special nod to sitting with our younger ones on Sunday mornings. It is a gift without price. As Jesus tells us:

"Let the little children come to me, and do not stop them; for it is to such as these that the kingdom of God belongs."

- Luke 18:16

Another spark of enthusiasm is the growing vision of what our Orchard Valley church home will look like in the (hopefully) not too distant future. The plans have drawn questions and ideas, hopes and eagerness.

2019 began with big changes in our denomination. As of January 1, 2019, the Presbyteries and Conferences of the United Church of Canada became Regions. Our former Valley Presbytery, part of the former Maritime Conference, was dissolved, and we welcomed in our new organization called "Region 15", encompassing Nova Scotia and Bermuda. While the rest of the regions across Canada have discerned a new name for their regions, we remain as Region 15 for the time being. As part of this new organization, I have been serving as a Liaison with the primary role of assisting other United Churches understand their needs, and then seek and find new ministry leadership. I am also part of the Future Directions Committee, where our mandate is to "Provide future directions, suggestions by oversight, leadership, and guidance for the Communities of Faith within the Region."

This year we entered into a great learning and engaging time as we gathered to study The Last Week, by Marcus J. Borg and John Dominic Crossan, a detailed study of the last week of Jesus' earthly life during our Lenten study session. This Committee was formed to work toward the Orchard Valley United Church becoming an Affirming Ministry. "Affirming ministries are congregations, presbyteries, Conferences, educational institutions, and other ministries within the United Church that publicly declare their commitment to inclusion and justice for people of all sexual orientations and gender identities. Although Affirming Ministries make an explicit statement about issues of sexuality and gender, their commitment to justice is far broader. They continually grow and change as they seek to live more fully into God's way of welcome, love and justice for all creation. Just as God rejoices in the goodness and diversity of creation, so too Affirming Ministries honour and celebrate diversity". (Taken from *Open Hearts: Resources for Affirming Ministries in the United Church of Canada*)

Our first Committee meeting was April 11, 2019. In subsequent meetings, we regretfully accepted the resignation of Heather Bishop and Scott Sweatman. Vicky Austin and Dale MacArthur became co-chairs.

# Mandate

Following the Affirming process used by the United Church of Canada, the Committee's mandate is to understand the need for, and the issues surrounding, congregational inclusion of the 2SLGBTQ+ community (2 spirit, lesbian, gay, bisexual, transsexual, and queer). The Committee then supports the congregation and other committees in their understanding of the issues for them to be prepared for a congregational vote on becoming a member of Affirm United.

#### **Vision Statement**

To join the Affirm United family of churches, and to encourage and support other congregations which are interested in exploring the process. To welcome and support all who want to worship in our congregation without exclusion.

#### **Mission Statement**

To take action to fulfill our Vision by educating, informing, witnessing and offering experiences for the congregation and the broader community.

#### **Activities to Date**

- The Committee worked very hard to develop the mandate, vision statement, and mission statement as above as the first part of our journey.
- Then the Committee had an afternoon educational session facilitated by the Valley Youth Project that covered the issues of *Gender Identity and Sexual Orientation*.

#### **Future Activities**

We hope to have a follow-up session – Creating Safer Spaces for 2SLGBTQ+ Communities – with the Valley Youth Project. Early next year (early 2020), we will be hosting a workshop for all interested members of the congregation. The workshop will focus on *the role and significance of scripture* in discussions of sexual orientation and gender identity.

We are on an exciting and challenging journey together towards inclusivity in our "open hearted" welcome and in our worship.

# 5.2 Christian Development Committee

This Committee works to provide stewardship of Orchard Valley's Christian development programs and to determine the educational and developmental needs of the congregation and initiate programs to meet these needs for all persons, at each stage of their lives.

Our main activities in 2019 were:

- Holding Sunday School, which included more teachers and quarterly teachers' meetings and a parents'/grandparents' meeting in the fall;
- Hosting a Camp sponsorship drive;
- Supporting four families attending one day of Sherbrooke Lake's family camp and sponsorships/support for nine children/youth attending Sherbrooke Lake's other camps (camping support included assisting with registration forms and providing gas money/transportation);
- Assisting our Seekers, our monthly middle-school youth group. They raised over \$2,000 and participated in the Coldest Night of the Year walk, had a BBQ at Hennigar's Farm Market in June, and had a Hallowe'en bake sale. They then took the bake sale proceeds and some unwanted church items to the SPCA Thrift Shop; and
- Performed a Christmas pageant for both worship times, with many thanks to Director Thea Burton.

Christian Development also supported the 9:00 am children and the Lectionary Study Group via Rev Don, participated in renovation discussions, had a youth-and-adult viewing of the 1973 movie *Jesus Christ Superstar*, assisted Worship Committee with a congregational picnic, assisted Congregational Life Committee with a Christmas children's lunch, and led seniors' worship services at Kings Riverside Court in November and Blomidon Court Shannex in December. Rev Don offered a confirmation class in the spring and one individual became Orchard Valley's first candidate for confirmation. Rev Don also led book studies in the spring and fall, which were all well attended.

Thank you to everyone who helped with these programs and activities! We especially appreciated all those who contributed to the camp sponsorship fund: the congregation donated \$3,767.35! We used \$2,520 of this to cover the 2019 camp sponsorships. The remainder will go to Orchard Valley's cabin commitment in 2020.

This year's *Stories From the Orchard* (pre-service slideshows that play for two consecutive Sundays) featured Mid-winter Mondays, Y'All Come to Supper, Easter Events and Services, the two Canucopia Food Bank Drives, High Tea in the Orchard, Sherbrooke Lake Camp, Tymchuk Pig Roast, Men's Group Turkey Supper, Louis Lightfoot's Retirement, Seekers Supporting the SPCA, Sunday School Play Practice and Fun Afternoon, Sunday School Christmas Pageant, and Christmas at Orchard Valley.

Committee members presided over the June 9 seniors' worship service at Kings Riverside Court in Kentville.

Special projects in 2019 included:

- Working on brochures/bookmarks/postcards about Orchard Valley for Acadia
   University and Nova Scotia Community College's Kingstec Campus. We are already in
   Acadia's Chapel booklet and plan to put an ad in the student newspaper, *The* Athenaeum, next September;

Committee meetings were held at 10:00 am, the second Tuesday of each month at OVUC.

The Covenanter is the oldest existing Presbyterian Church building in Canada and is an object of great pride to the local community. It is a registered Provincial Heritage Building and a National Historic Site and, as such, is an active tourist destination for local and international travelers. Because of its historical importance, the Committee would like the Covenanter to remain a living church by maintaining ties with the United Church of Canada. Currently the responsibility of the Orchard Valley Pastoral Charge, the Covenanter has unique sources of funding and management. The Covenanter Church is a trust of Orchard Valley Pastoral Charge Trustees and is managed by the Covenanter Committee. The Committee has representation from OVPC Trustees as well as the OVUC Worship Committee. The Covenanter has been financially self-sufficient through the Heritage Fund set up to receive and disperse monies for repairs and maintenance. Funding is from a variety of sources including offerings, donations, special services, weddings, fundraising, bequests, memorials and government grants.

The proper care and maintenance of the Covenanter is always a priority of the Committee and OVPC Trustees.

In 2019, we held seven meetings. We facilitated the Kirkin' o' the Tartan in June. Four weddings were held May through November at the Covenanter.

During the summer months of July and August, we presented our summer worship services, which consisted of eight worship services with a variety of pulpit supply. These services were very well received by the congregations present. In addition, a Christmas Eve Service was conducted by Rev Don Sellsted and Rev Tim McFarland. It was a full-capacity crowd. Ken Hassell played the organ and directed the choir and Church chimes. Caroline Burton was our guest soloist. Parking monitor was Jim Keech, assisted by John Burdock.

We were shocked and saddened by the death of our Chair, Ernie Draper on December 5, 2019. This was a big loss to our Committee and community. Ernie's memorial was held at the Covenanter Church on December 10 and a reception was held at the local community centre. Beth Crosby will be Acting Chair for the next few months until we have a new person in place.

We were concerned for one of our Committee members, Dorothy Robbins, who had a fall this past autumn. However, she is slowly recovering and we hope to see her soon.

The Committee needs to recruit one or two new members.

# **Covenanter Church Building Coordinator's Report**

The Covenanter Church has now entered its 216<sup>th</sup> year. In order to stand for so many years on "Kirk Hill", the Covenanter has undergone countless inspections, repairs and upgrades as it overlooks the community of Grand Pré.

This year an inspection by a drone with a camera revealed that the tower is going to need painting of the cupola. We will also need a new roof for the tower, cupola and spire. Presently, the three roof surfaces are covered with asphalt shingles. Initial estimates from a number of contractors for the project put the cost in the \$50,000 range. Since asphalt shingles have a standard lifespan of 15 to 20 years, the Covenanter Committee is investigating the use of other roofing materials which have a much longer lifespan.

Consultations have started at both the national and provincial levels, as to materials, regulations and available grants to help cover (hopefully) at least half the cost or more. Start time for the project is slated for 2021.

As well, our five-year plan has proposed the replacement/repair of the ridge boards, placement of the zinc oxide strips to deter mould growth on the cedar-shake roof, and some cedar shingle replacement all on the main roof of the church.

Some proactive construction will take place this year beside the tower entrance and beneath the sanctuary floor.

Finally, we would like to thank those in our community who have volunteered their labours for the Covenanter Church.

#### **Covenanter Church Heritage Fund Treasurer's Report**

The Covenanter Church Committee has been preparing a 2020–2025 Capital Repair Plan. In 2020, the Covenanter Committee will be seeking quotes and applying for grants for major repairs to the Covenanter Church. The OVUC Finance Committee, Board of Trustees and Church Council have approved an expenditure of up to \$60,000 for major repairs to the Covenanter Church, as stated in the Building Coordinator's Report.

Contact has been made with the National Cost Sharing Program for Heritage Places with encouraging results: an offer of specialist advice on materials, etc., on adherence to Standards

and Guidelines for Heritage Buildings, and assistance "in completing" or "with" the grant form. Other means of funding will be sought.

At least 50% of the cost could be covered. Covenanter Heritage investments can cover the full amount if necessary. 2019 updated details of these investments will be reported in the Trustees' Annual Financial Report.

The project is scheduled to be completed between April 1, 2020, and December 31, 2021. The grant application is due in the fall of 2020. The following items need to be completed before the grant application deadline:

- The expenditure of up to \$60,000 must be presented to the congregation for their information and approval;
- The Region 15 application form for approval must be presented to the Region 15 Property Committee for approval. It will be ready for their March 6 meeting; and
- Region 15 Council approval would be based on the Region 15 Property Committee's recommendation. That meeting is in early May.

It is my pleasure to report to the congregation representing members of the ad hoc OVUC Facilities Committee. One of the original members, Peter Morse, had to step down from the Committee due to work conflicts. The Facilities Committee has not appointed a Chair or Secretary; Harvey Gilmour has served as meeting co-ordinator and secretarial duties have been shared.

The Facilities Committee mandate from Church Council is to develop an acceptable and affordable architectural vision for OVUC to rehabilitate our present facilities, enhance them and add to them if warranted. The Facilities Committee is the first step in a process of designing, developing a financial campaign plan, and constructing a new "home" for OVUC.

The Facilities Committee met ten times in 2019 (including a December 8 presentation to the congregation) each time with the representatives of B.D. Stevens Ltd. The latter was represented throughout by design architect Cory MacFadden, with design architect Mark Hughes also attending two of the meetings.

The design phase included enhanced outcomes from each of the ten meetings and included presentations from Cheryl Manzer (Outreach / kitchen), and Andy Pitter and Cheryl Hill (representing the Sunday School team). Parts of two meetings addressed Ken Hassell's ideas about Choir support facilities. The interim design was presented to the congregation and received enthusiastic support.

(Subsequently, on January 6, 2020, the Facilities Committee received direction from a meeting of Trustees, Facilities Committee, and representatives of Council to limit financial commitments which will require major adjustments down from the first design estimate of \$2.1 million.)

The Facilities Committee expresses gratitude to Thane and Scott Stevens of B.D. Stevens for the generous gift offer of more than an acre of land abutting present church boundaries, which will allow some extension of our building in a south-easterly direction, extra parking space, and for ease-of-access and beautifying exposure to the church from Cornwallis Avenue.

The Facilities Committee will continue to meet throughout 2020 until it has achieved a futuristic design that meets needs as prioritized by the congregation and is a road forward that can be accompanied and supported by an acceptable financial plan.

#### **Benevolent Fund**

During 2019, we had 23 requests for support. Fifteen of these were for food. Three of these individuals requesting food did not receive support, as one did not qualify due to being outside our area, one we could not reach, and one did not arrive to pick up the voucher. We respond to calls at least three times. If we are not able to reach anyone on the third try, a message is left (if possible) letting them know they will have to call the Outreach line again and leave another message. The total provided in food for the other eligible 12 people totalled \$880.

Two requests for oil came in during this year. We had \$200 worth of oil delivered to one person and unfortunately were not able to contact the other person. There was also one request for power and \$150 was paid directly to the power company on their behalf.

We also supported someone in getting a bite plate for \$300 and helped another person by providing them with \$150 for their damage deposit for a new apartment.

#### Canucopia

This was another successful year for Orchard Valley United Church's Canucopia Food Drives. Both food drives (one in the Spring and the second in the Fall) took place at the local grocery stores. The OVUC Pastoral Care Committee, in partnership with the Ministry Team, coordinated pastoral care visitation to members of the congregation (and other United Church of Canada people living in our communities). The Pastoral Care Committee encouraged and supported OVUC home, hospital, and institution visitations, while providing a nurturing environment for both the visiting volunteers and those being visited.

Our Committee mandate was reviewed and no changes were made.

All members of the Pastoral Care Committee have the requirements for the Duty To Care Program.

The Committee met monthly except for the summer months. The meetings all started with a meditation and ended with a blessing and prayer circle. We reported to the OVUC Council and attended the Council meetings. Bills for expenses were forwarded to Council for payment from the 2019 budget.

We hired Kings Point-To-Point Transit to bring OVUC members to church. We organize people to provide hospitality to these folks by meeting them at the door, sitting with them during the worship services, and seeing them safely out to the awaiting drivers afterwards. Cab transportation has been provided for church families to attend church functions. Committee members provided drives to church functions also.

Nursing home Worship Services for seniors were attended by Committee members who provided assistance when needed. Bulletins were hand-delivered to nursing homes, assisted living homes and private homes for members unable to attend church. Visits in private and nursing homes, community, and church were done. Cards were sent, telephone calls were made, funerals were attended and emails were sent. Hospital visitations by Committee members were conducted on an as-needed basis.

The Pastoral Care Committee provided leadership at the worship service at the Kings Riverside Court Assisted Living Facility in March and Greenwich Shannex in January. This was followed by tea and cookies so that the residences could meet Rev Don.

The **Journeying Through Grief** books (four short books per set) are available for Committee members to share with people at four crucial times during the first year after a loss.

Pastoral Care's two sub-committees were the Prayer Shawl Ministry and Spirit Yoga. They added to the experiences of our caring community at Orchard Valley United Church.

People sought to experience the healing benefits and unique wisdom offered to us by both Christianity and the Yogic tradition through Spirit Yoga. Monies collected from Spirit Yoga were directed to be used for Pastoral Care.

The Prayer Shawl Ministry group met once a month throughout the year, except August and December, under the leadership of Jean Millett and Helen Seymour. The average attendance was five people per occasion. Meetings were held at 7:00 pm on the third Tuesday of each month. There were a total of 31 Prayer Shawls or Prayer Squares given out this year. Of these, four were given to announce a baptism, birth or other celebration; 12 were given as an expression of caring to those who were ill, recovering from surgery or injured; and 15 were given as a comfort at a time of loss or the occasion was not recorded. We would welcome anyone who enjoys knitting or crocheting to drop by for a hour or so of friendship. Yarn and patterns are available at the church for those who prefer to work at home.

The Pastoral care members helped with the October Y'All Come to Supper event.

Rev Don and Pastoral Care hosted a Longest Night of the Year Service on December 22. Approximately 30 individuals attended this service.

Gail & Garth Gordon presented the Committee with a draft on *Steps to Take After a Death*. This will be used by Rev Don and may be added to our Grieving Booklets.

A program called "You've Got A Friend" (to help OVUC Church members to keep in touch with each other) was organized by Vera Burke, Linda Draper and Allyson Dunfee. Thank-you to our callers: Susanne Sweatman, Lois Tracy, Peter Dekker, Edie Lloyd, Vivian MacPhee, Edna Roach, Eleanor and Ned Chase, Linda Draper, Linda Swindells, Peggy Jones, Anne Clattenburg, Helen Hansford, Fran Turner, Betty Rockwell, Margaret Curry, George and Allyson Dunfee, Cheryl Sellsted, Linda Draper, and Gloria Hick.

#### **Christmas Giving Tree**

With each donation, we exchange a red ribbon on the tree for a white one. The goal is to have a tree full of white ribbons by Christmas Day. # 6.1 Orchard Valley Men's Group

The OVUC Men's Group have an active following of 10 men. We participate in the following activities within the church:

- *Christmas Hamper Program*: Registration got underway in mid October and continued in early December. This program is coordinated by the Salvation Army. 511 Christmas Hampers were processed.
- **Good Neighbour Energy Home Heating Program**: This program is also administrated by the Salvation Army with the funds being provided by the NS Power for clients who have qualified for financial assistance with their heat.

#### 6.7 Valley Foodgrains Bank Project

The Valley Foodgrains Bank Project (VFGBP) has been a multi-faith and community project since its inception. Churches in the area taking part in projects are Orchard Valley United, Berwick United, Woodville United, Kentville United Baptist, Bethany Baptist, St. James Anglican and Kings Presbyterian. The VFGBP works under the direction of the Canadian Foodgrains Bank (CFGB). The CFGB is a partnership of 15 churches and church-based agencies working to end global hunger by: supporting international programs to meet immediate food needs, reduce malnutrition, and achieve sustainable food security, influencing improvements in national and international policies that contribute to ending global hunger; and increasing and deepening the engagement of Canadians and to end global hunger.

**Pumpkin Sales**: \$575 was donated by the Kentville United Baptist Church from the sale of pumpkins, by the Youth Group. Pumpkins were donated by the Stirling Fruit Farms.

**Fall Frozen Blueberry Sale**: 45 boxes of frozen blueberries from Blueberry Acres were sold. Churches taking part were Orchard Valley United, Berwick United, Kentville United Baptist, Bethany Baptist, St James Anglican and Kings Presbyterian. Five pound boxes of frozen blueberries were sold for \$20, with \$4 going to the Canadian Foodgrains Bank. The second sale of the year will take place in February. A donation of \$250 was made by a member of Orchard Valley United. All donations are matched 4:1. This year, we were able to give a donation of \$1,000 to the Canadian Foodgrains Bank.

#### 1. Nature of operations

Effective July 1, 2012, the Orchard Valley Pastoral Charge was formed to effect the amalgamation of four United Church of Canada Pastoral Charges located in Eastern Kings County Nova Scotia.

These financial statements reflect the activities related to the operations of Orchard Valley Pastoral Charge. The activities of the Trustees Fund managed by the Orchard Valley Pastoral Charge are not included in these financial statements and are reported in separate financial statements.

#### Summary of significant accounting policies

These financial statements were prepared in accordance with the Canadian accounting standards for not-for-profit organizations in Part III of the CPA Canada Handbook and include the following significant accounting policies:

#### Cash and cash equivalents

Cash and cash equivalents include cash on hand and balances with banks, bank overdrafts, and highly liquid temporary money market instruments with original maturities of three months or less. Bank borrowings are considered to be financing activities.

#### Equipment

Equipment is accounted for at cost and amortized on the basis of their useful life using the following methods and rates:

Fixtures and equipment Computer equipment 20% Declining balance 30% Declining balance

#### Financial instruments

The organization initially measures its financial assets and financial liabilities at fair value adjusted by, in the case of a financial instrument that will not be measured subsequently at fair value, the amount of transaction costs directly attributable to the instrument.

The organization subsequently measures all of its financial assets and financial liabilities at amortized cost.

Amortized cost is the amount at which a financial asset or financial liability is measured at initial recognition minus principal repayments, plus or minus the cumulative amortization of any difference between that initial amount and the maturity amount, and minus any reduction for impairment.

Financial assets measured at amortized cost include cash and cash equivalents, and receivables.

#### Summary of significant accounting policies (continued)

#### Financial instruments (continued)

Financial liabilities measured at amortized cost include accounts payable and accruals.

Financial assets measured at cost are tested for impairment when there are indicators of impairment. Previously recognized impairment losses are reversed to the extent of the impairment provided the asset is not carried at an amount, at the date of the reversal, greater than the amount that would have been the carrying amount had no impairment loss been recognized previously. The amounts of any write-downs or reversals are recognized in net income.

#### Revenue recognition

Orchard Valley Pastoral Charge follows the deferral method of accounting for contributions. Contributions are recognized as revenue when they are received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Rental revenue is recognized when the services have been provided

Volunteers contribute significant hours to assist Orchard Valley Pastoral Charge in carrying out its activities. Because of the difficulty of determining their fair value, contributed services are not recognized in the financial statements.

#### Use of estimates

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any adjustments necessary are reported in net revenues and expenditures in the period in which they become known. Actual results could differ from these estimates.

#### Fund accounting

The Unrestricted Fund accounts are for the organization's program delivery and administrative activities. This fund reports unrestricted resources

Restricted contributions and resources and internally restricted resources are reported in the Restricted Funds.

#### Revenue recognition

Orchard Valley Pastoral Charge-Trust Funds follows the restricted fund method of accounting for contributions.

Restricted contributions are recognized in the fund corresponding to the purpose for which they were contributed. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Changes in fair value are recognized in net revenues and expenditures in the period the changes occur.

Amortized cost is the amount at which a financial asset or financial fiability is measured at initial recognition minus principal repayments, plus or minus the cumulative amortization of any difference between that initial amount and the maturity amount, and minus any reduction for impairment.

Financial assets measured at amortized cost include cash and cash equivalents and receivables.

Financial liabilities measured at amortized cost include accounts payable and accrued liabilities and long-term debt.

Financial assets measured at fair value include investments. The fair values of investments are determined by reference to the latest closing transactional net asset value of each investment.

Financial assets measured at cost are tested for impairment when there are indicators of impairment. Previously recognized impairment losses are reversed to the extent of the impairment provided the asset is not carried at an amount, at the date of the reversal, greater than the amount that would have been the carrying amount had no impairment loss been recognized previously. The amounts of any write-downs or reversals are recognized in net revenues and expenditures.

#### 8. Financial instruments

The organization is exposed to various risks through its financial instruments. The following analysis provides a measure of the organization's risk exposures and concentrations at December 31, 2019.

#### Market risk

Market risk is the risk that fair value or expected future cash flows of a financial instrument will fluctuate because of changes in the market prices. Market risk comprise three types of risk: currency risk, interest rate risk, and other price risk. The organization is mainly exposed to interest rate risk and other price risk.

#### i) Interest rate risk

Exposure to interest rate risk arises on financial assets and financial liabilities recognized at the reporting date, whereby a future change in interest rates will affect future cash flows or the fair value of fixed rate financial instruments. The organization is also exposed to earnings volatility on floating rate instruments. There was no significant change in exposure from the year prior.

### ii) Other price risk

Other price risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices (other than those arising from interest rate risk or currency risk), whether those changes are caused by factors specific to the individual financial instrument or its issuer, or factors affecting all similar financial instruments traded in the market. The organization is exposed to other price risk through its investments quoted in an active market.
